## I. PURPOSE

This Solicitation for Information (Solicitation) by Campbell County, Virginia, herein after referred to as the “Locality” invites private-sector internet service providers to submit letters of interest as co-applicants, with the locality, to take advantage of the Virginia Telecommunications Initiative to implement a program to expand Broadband services within the Locality.

The period of any potential resulting contract(s) or partnerships from this Solicitation will be as negotiated by the Locality and the selected partner(s) after the application process has been completed and accepted.

A letter of interest should include:

- Proposed unserved project areas by geographic boundaries
- Describe the internet service offering, including download and upload speeds
- Additional relevant information about the service your company will provide

Any private-sector internet service provider interested in applying with Campbell County for FY2022 VATI funds are asked to submit a Letter of Interest addressed to Frank J.
